## Memorandum of Understanding on Academic Cooperation Between

## The Parties:

Hooghly Women's College (Hereinafter "HWC"); and Khalisani Mahavidy laya (Hereinafter "KM") recognizing the benefits to their respective institutions from the establishment of ir ernational links, concludes this Memorandum of Understanding (hereinafter: "MOU").

1. The purpose of this MOU is to develop academic and educational coopera on and to promote mutual understanding between two parties.

- 2. Each party agrees to develop the following collaborative activities in the acadenic areas of mutual interest
- on a basis of equality and reciprocity.
- a. Exchange of academic and administrative staff.
- b. Exchange of students and transfer of Academic credits.
  - c. Conducting collaborative research projects.
  - d. Conducting lectures and organizing symposia.
- e. Exchange of academic information and materials.
  - f. Promoting collaboration in the fields of mutual interest.
- g. Promoting other academic cooperation as mutually agreed.

3. The development and implementation of specific activities based on thi MOU will be separately negotiated and agreed between colleges which carry out the specific projects and ill be subject to a separate written agreement. Each party agrees to carry out these activities in accordance with the rules and regulations of the respective colleges after fall consultation and approval.

4. It is understood that the implementation of any of the types of cooperation stated in Clause 2 shall depend upon the availability of the resources and financial support of the parties concerned.

5. Both parties agree that prior written approval is required before using the c her party's name. Logo or other intellectual property rights in any advertising or associated publicity.

6. Should the collaborative research activities under this MOU result in at / potential for intellectual property, each party and equitable and fair agreement as to ownership and other property interests that may arise.

7. This MOU can only be amended or modified by written agreement signed by the representatives of each party.

8. This MOU is valid for a period of 5 years from the date of signing by the authorized signature of each party. Each party shall review the status of the MOU at least three months before the end of the five-year period to determine whether it wishes the MOU to continue and, if so, any modifications t at might be necessary. The period of validity of this MOU only be extended by the mutual written consent of bot a parties.

9. This MOU may, at any time during its period of validity be terminated by one of the parties upon prior notice to the other in writing not later than 6 months before the termination date.

10. The parties may disclose certain confidential information to the other in rel tion to any future proposal made under this MOU. Each party therefore agrees that the contents of this MOU an the negotiations in relation to any future proposal may remain strictly confidential and each party hereby undertakes not to disclose the same to any third party, save for its professional advisors, without the prior written constant of the other party except where such disclosure is required by law (including without limitation, under applied ion freedom of information legislation).
