Hereinafter individually referred to as "The Party" and jointly referred to as "The Parties":

DESIRING to engage in intercooperation between "The Parties" in Educational Exercises, Academic and Training Programmes and Research Activities,

HAVE CREATED THIS LINKAGE on the basis of the following understanding:

Article 1

OBJECTIVE OF COOPERATION

The objective of this LINKAGE is to co-operate each other in educational projects in areas of mutual interest.

Article 2


SCOPE OF COOPERATION


The Parties agree to implement co-operative programmes including but not limited to:

- Faculty and student exchanges.

- Access of students of both institutions to quality enhancement programmes organized at both the institutions.
- Undertaking Joint Research Programmes where possible.

Article 3

Article 4

MODE OF CONDUCTING THE PROGRAMMES

The programmes will be conducted primarily in the Offline mode. Ample arrangements should also be made to conduct programmes in the Online mode, if required.

Article 5

DURATION AND TERMINATION

- 1) This LINKAGE shall enter into force on the date of signing.
- 2) The LINKAGE shall remain in force for a period of five (5) years and may be extended for another period of five (5) years by the mutual written consent of the Parties.
- 3) Either Party may terminate this LINKAGE at any time by giving written notice to the other Party on its intention to terminate this LINKAGE, at least six (6) months prior to the date of the termination.
- 4) The termination of this LINKAGE shall not affect the completion of any project/s and programme/s in progress and not completed at the time of termination.

Article 6


AMENDMENT
