MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding ('MoU') is made and entered into on this 24th day of May 2023 by and between IQAC, Khalisani Mahavidyalaya, Khalisani College Road, Chandannagar, Hooghly, West Bengal – 712136 and Tally Institute of Learning Chinsurah (ROY'S INFOTECH), Khadinamore, G.T. Road, Chinsurah, Hooghly, West Bengal – 712102.

Purpose, Scope and Terms and Conditions

The purpose of this Memorandum of Understanding is to set forth the terms and conditions, scope of work and responsibilities of the parties associated with their collaboration on training and workshop sessions for students related to Accounting Package (Tally) and related matters. The 'MoU' will remain effective for 2 (Two) years. Training and Workshop Sessions would be conducted at Tally Institute of Learning Chinsurah (ROY'S INFOTECH) on the basis of mutual consent.

The 'MoU' may be extended or revised after every 2 (Two) years on mutual discussion between the two parties viz. IQAC, Khalisani Mahavidyalaya and Tally Institute of Learning Chinsurah (ROY'S INFOTECH).

In case of any dispute resulting from or related to this 'MoU', the parties agree to attempt to resolve such dispute amicably, and shall escalate within their respective organizations, any such dispute. This 'MoU' shall be governed and construed according to the law of the country for each participating party. Any dispute will be jointly resolved involving the IQAC, Khalisani Mahavidyalaya and Tally Institute of Learning Chinsurah (ROY'S INFOTECH) in a spirit of independence, mutual respect, and shared responsibility.

No financial commitment is required / involved to execute the terms and conditions of the 'MoU'.

The 'MoU' may be terminated by either party after giving a notice of three months (90 days) provided that this clause will be operative only if either party violates the terms and conditions of 'MoU' or if the parties feel that no useful purpose would be served by further continuing it either due to change in circumstances or change in consulting parties.
